## **DIRECTIONS TO ROCKING L RANCH: 6767 Palae Lane, Cocoa Florida**

**From the North:** I-95 to Pt. St. John exit, then turn left, go to light at Grissom Parkway and turn right, go to traffic light and turn right onto Canaveral Groves Blvd., go to stop sign and turn left on Lee St., go to stop sign then turn right on Citrus Blvd to 4 way stop then go straight on Citrus to stop sign and turn right on Osprey Ave., take 1<sup>st</sup> left onto Brickel Ln., then road turns left into Spire Ln., then road turns right into Palae Ln., go to the end of the road through the gate.

**From the South:** I-95 to SR 524 west to Adamson Rd and turn right, go to the end and the road turns left into Coconut Ave., go ¼ mile and road turns right into Pine St., go to 4 way stop and turn left onto Citrus Blvd., go to the end of Citrus and turn right onto Osprey Ave., take 1<sup>st</sup> left onto Brickel Ln. then road turns left into Spire Ln., then road turns right into Palae Ln., go to the end and through the gate.

## **BASIC INFO:**

**Arrival time at the Rocking L Ranch is 7:45 am Monday – Friday.** Drop off will take place in the large arena. Signage will be visible to assist with this process. Please be prompt as we will begin our activities *promptly* at 8:00am. Be ready to hand any medications you may have for your child to the Director of the camp. Please read the directions for handling medications and have them in a Ziploc bag that is clearly labeled. You will **not** need to leave your vehicle for this. **There will be a quick check for lice once your child has arrived at camp on Monday only. Please be aware if we find lice your child will not be able to attend the camp and you will be called to come and pick your child up. In the event this happens, there will not be a refund.**

**Pick-up time at the Rocking L Ranch is 12:30pm Monday – Thursday** You will enter the arena the same as drop off and your child will be there waiting for you. **Please be prompt.** **NOTE: Friday's pick-up time is 1:30pm.** Friday is the only day we go longer due to the lunch provided.

## Proper Camper Behavior

Camp is a fun time for everyone. Poor behavior will be addressed appropriately. If the offense is serious (arguing, verbally offensive, harming others, harming property, harming the animals, etc.) or a second minor offense the camper will see the Camp Director who will contact the Parents/Guardians for assistance. At any time, the Director shall exercise full discretion, including having serious or repeat offenders sent home from camp without reimbursement.

## Temporary Check-out from Camp

If it is absolutely necessary for your camper to depart camp early, he/she must be signed out by the parent/guardian that checked him/her into camp. Valid ID must be shown to the Camp Director, Bonnie Goolsby.

## What to bring:

- (VERY Important) **Medicines, inhalers, EpiPen**. NO loose unmarked medicines. All meds must be in original pharmacy containers with the prescription and camper's name indicated. Put meds in a clearly labeled Ziploc bag.
- **SIGNED/NOTARIZED MEDICAL INFORMATION & PARENT CONSENT FORM MUST BE RECEIVED WHEN PAYMENT IS MADE.**

- **Arrive in clothing** suitable for horseback riding. The following is proper attire:
  - ✓ **Boots or Tennis Shoes** (Must be closed toed)
  - ✓ **long shorts** – no short shorts



- ✓ **camp t-shirt**
- ✓ **Limited jewelry** (Please no dangling earrings, bracelets or necklaces that could easily get caught on things.)
- ✓ **Hat-** ball cap, visor, cowboy hat☺
- ✓ **Helmets *are provided by RLR*, but if you own one or have a bicycle helmet, these are encouraged. Everyone will be required to wear a helmet to ride the horses☺**
- ✓ **Sunscreen!!!** We suggest at least 30 SPF and the sport, long lasting kind. Please have sunscreen applied to your child before arriving at camp. You may send the sunscreen with your child for reapplication if necessary.
- ✓ **Bug spray** (Recommend: OFF! Botanicals with No Deet for young children, "No See 'em", or 50:50 mixture of Avon Skin-So-Soft and rubbing alcohol).

• **Friday Only**

- ✓ **Swimsuits:** modest swimsuits are required, 1 piece for girls or a tee-shirt to fully cover a two piece. **Friday only.**
- ✓ **Beach towel- Friday only**
- ✓ **Change of clothes:** We will be involved in water activities on **Friday**. Your child may want to change into dry clothes.
- ✓ **Flip flops or water shoes** for the water activities on **Friday**.

**What to leave at home:**
